PUBLIC NOTIFICATION

ROLL CALL

The Committee meeting commenced at 6:38 PM. All six voting committee members were present at the beginning of the meeting.

APPROVAL OF PREVIOUS MINUTES

Minutes from the May 24 Shade Tree Committee Meeting were approved unanimously.

OLD BUSINESS

Species List

- Committee spent majority of the meeting collaborating to review the species list.
- Hardiness:
 - o The committee recognized the importance of avoiding planting trees susceptible to disease, such as Beech trees, which are failing in NJ.
 - o The committee agreed on the promotion of native species throughout the greenification process as much as possible
 - ex. honey locust, red maple, redbuds
 - o Swamp White Oak is the only Oak tree option that thrives in urban setting.
 - o Question raised regarding the lack of Evergreens on the list.
 - Edward O'Malley, Jersey City Forester, responded that Evergreens, which are gymnosperms, are more likely to fail in Jersey City. When compared to deciduous trees, they are not the best option for street.

• Edits to list:

- o Sweet Bay Magnolias changed to good for park, not for street.
- o Bald and Pond Cyprus are listed as *good for park, not for street* due to its likeness to water and moist soil.
- o English Oak noted to be *slender*, *good with powerlines*.
- Sargent Cherry "recommended" column contents removed, noted to have no pink flare, dies in two years.

Post-List Initiatives

- Separate List:
 - O The group would like to work towards creating a separate list to identify the best trees for planting in parks vs. streets for planning reference.

• Education:

- o Committee expressed interest in developing an educational campaign to discuss the ecological benefit of certain tree species, tree maintenance, and the value of greenification with the public and developers.
- o This initiative would promote environmental health in Jersey City through community outreach and education by providing resources for the public to make informed decisions when choosing their species.

- Adding more columns:
 - Question raised regarding adding more columns for an overall expansion of data on the traits of the species, including tree color, fragrance, hardiness, and its potential for carbon sequestration.
 - o It was concluded that it would be best to include such information in a separate list later, once resources for these traits are identified (especially for carbon sequestration).

Forestry Standards

- Benefits of a Forestry Department:
 - O There would be significant benefit to hiring someone responsible for forestry permits and enforcement of standards, especially with developers, to oversee compliance and tree health. However, staffing and budget are major obstacles for this initiative.
- Reni Stoll, Sustainable Jersey City representative, suggested the utilization of SJC's volunteer base and Open Tree Map application for street tree assessments.
 - o Doing so would require a city forester to confirm all data, along with the mobilization of volunteers to perform the data collection.
- Maintenance Section:
 - o The group revisited the Maintenance Section for finalization.
 - The group reiterates that the Maintenance Section of the Standards addresses the responsibilities of the developers who receive trees.
 - O Questions raised regarding the enforcement of tree care by developers.
 - To enforce compliance, the city performs an initial inspection after planting. However, further inspection process is unclear.
 - The planning board obligates the property owner to care for their tree, after it is planted, through a legally binding agreement.
- Old business wrapped up with the desire to conclude the maintenance piece of the standards document before the next meeting.
 - o The Standards will receive a final review by committee members to ensure that the language holding contractors to their maintenance obligation is sufficient.

NEW BUSINESS

- Forestry standards need to be cleaned up as soon as possible. The group estimates this to be completed before Friday July 9th.
 - o The group will attempt to organize a private meeting via Zoom to discuss final changes before submission.
