***Vaccination and Licensing Services to be Offered at City Parks; Free Rabies Shots for the First 250 Jersey City Cats and Dogs at Each of the Three Events***

JERSEY CITY – **Mayor Steven M. Fulop** and the **Department of Health & Human Services**, in partnership with the **Liberty Humane Society**, is pleased to announce **Jersey City’s Pet Partnership Days**, a series of pet vaccination and licensing events being held in City parks.

“In Jersey City, we have a devoted pet owner community, and know how important pets are to our many of our residents,” said **Mayor Fulop**. “Through the Pet Partnership Days, we are bringing our animal services to the community on the weekend, making it easier for residents to vaccinate and license their pets, so they can remain healthy and active.”

Pet Partnership Days will be held on the following dates at sites indicated:

**SATURDAY, APRIL 25th**, 10 am to 3 pm, Pershing Field (210 Central Ave.)

**SATURDAY, MAY 16th**, 10 am to 3 pm, Audubon Park (2000 Kennedy Blvd.)

**SUNDAY, MAY 31st**, 10 am to 3 pm, City Hall Park (280 Grove St.)

All events will be held outdoors, rain or shine. In cases of more severe weather, please check for possible cancellations with the Department of Health and Human Services by calling (201) 547-6800.

**Highlights:**

- Free rabies vaccinations for the first 250 dogs and cats at each location
- On-site dog licensing (check, money orders, or cash), bring proof of prior vaccination or licensing to qualify for 3-year license
