### **Eviction**

With limited exceptions, the New Jersey (N.J.S.A.2A:18-61.1 et seq.) protects your right to remain in your home. Foreclosure alone is not a ground for eviction of a tenant. This law protects you even if you do not have a written lease.

Examples of "Good Cause":

- Failure to pay rent
- Willfully damaging the premises

Self-help evictions in the State of New Jersey are not permitted. A residential tenant in New Jersey can only be evicted once a landlord has given them a Notice to Quit and has filed for eviction with Superior Court. Only once a landlord has been granted a Judgement for Possession can the landlord have the tenant evicted from the rental premises.
